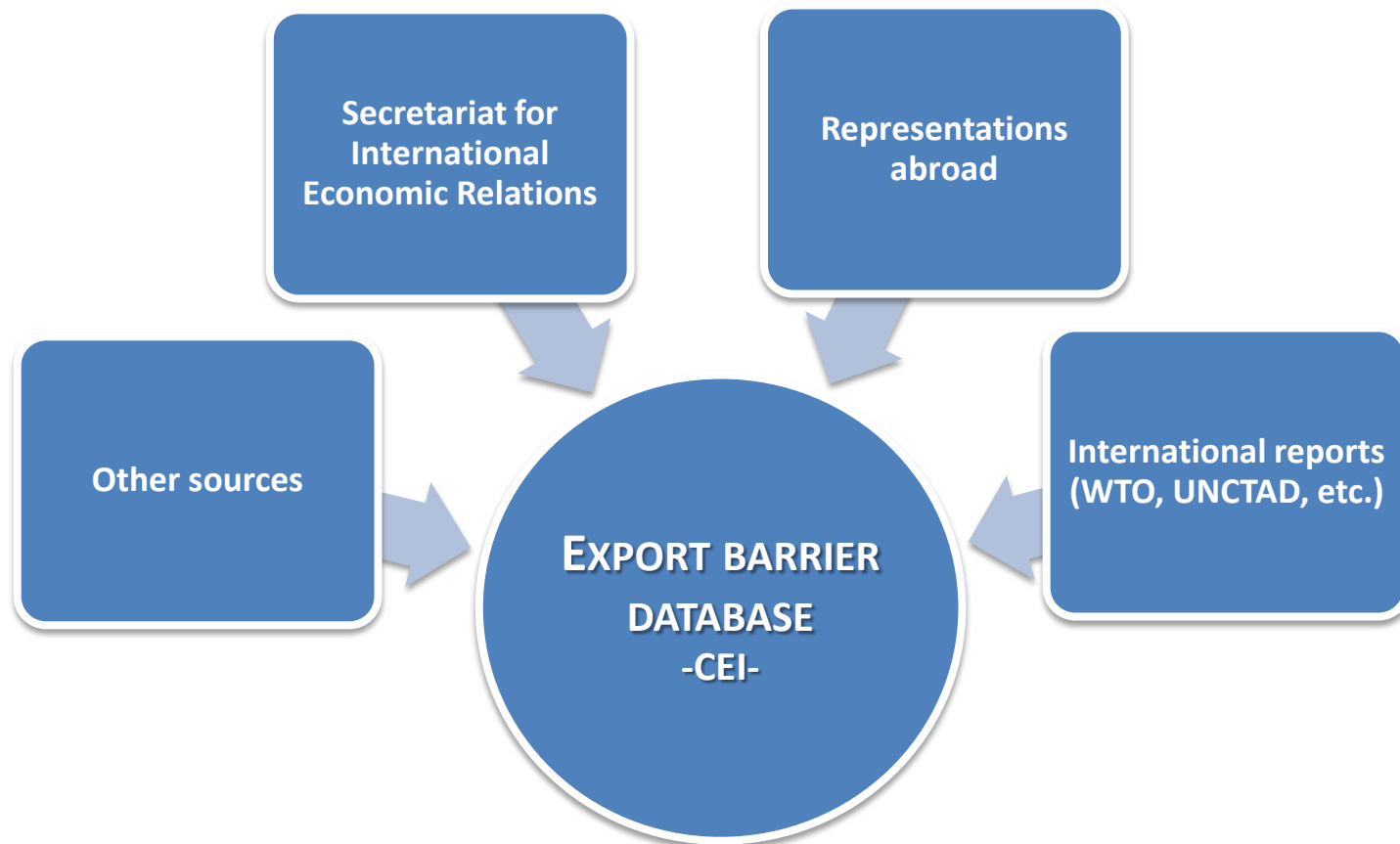

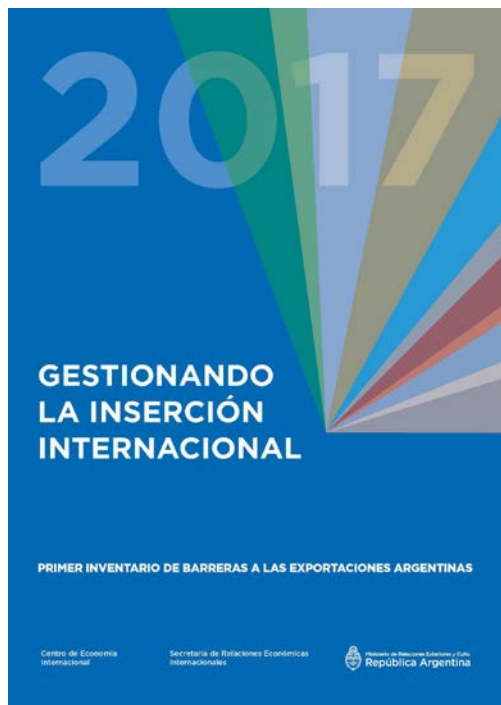

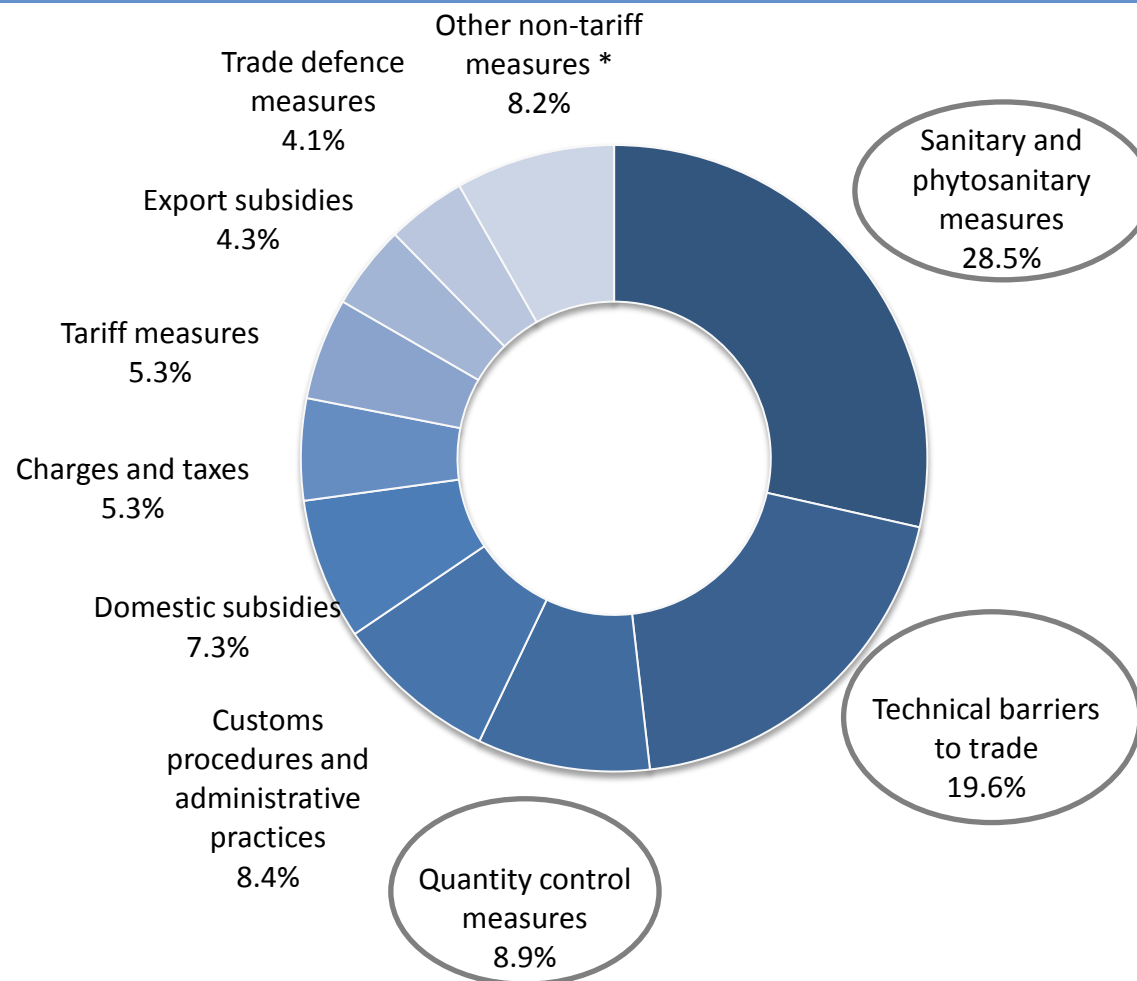

## FIRST EVALUATIONS - Measures recorded, in force in 2016, by type of measure

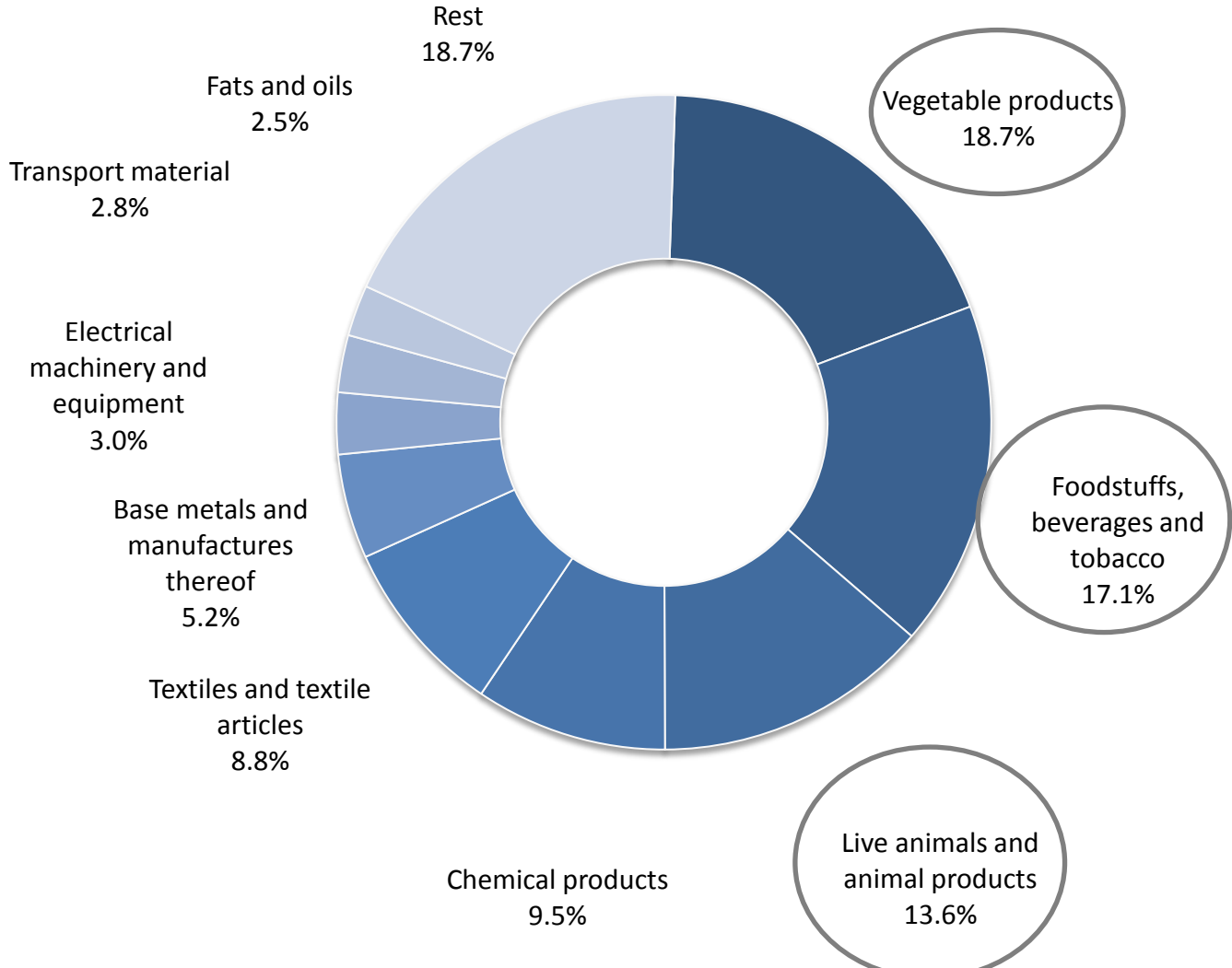

## FIRST EVALUATIONS - Measures recorded, in force in 2016, by economic sector \*

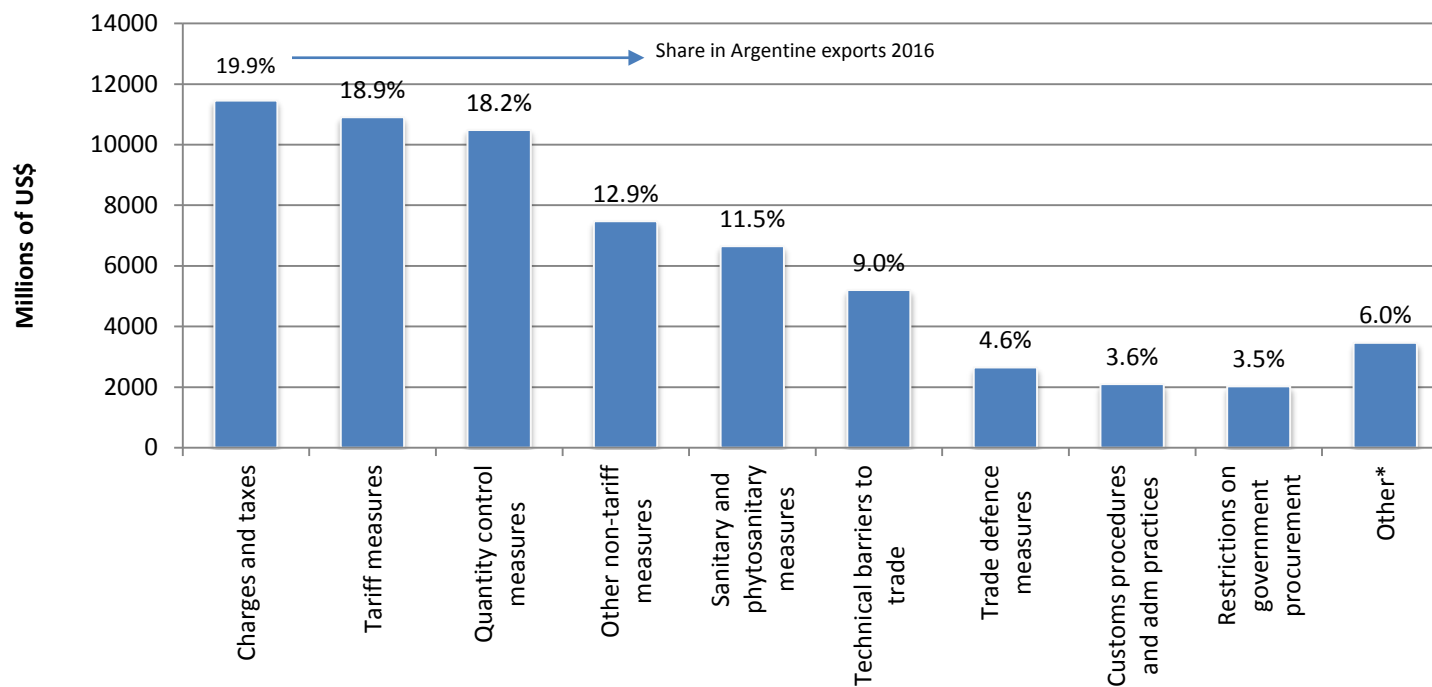

## FIRST EVALUATIONS - Exports covered by the measures recorded, by type of measure

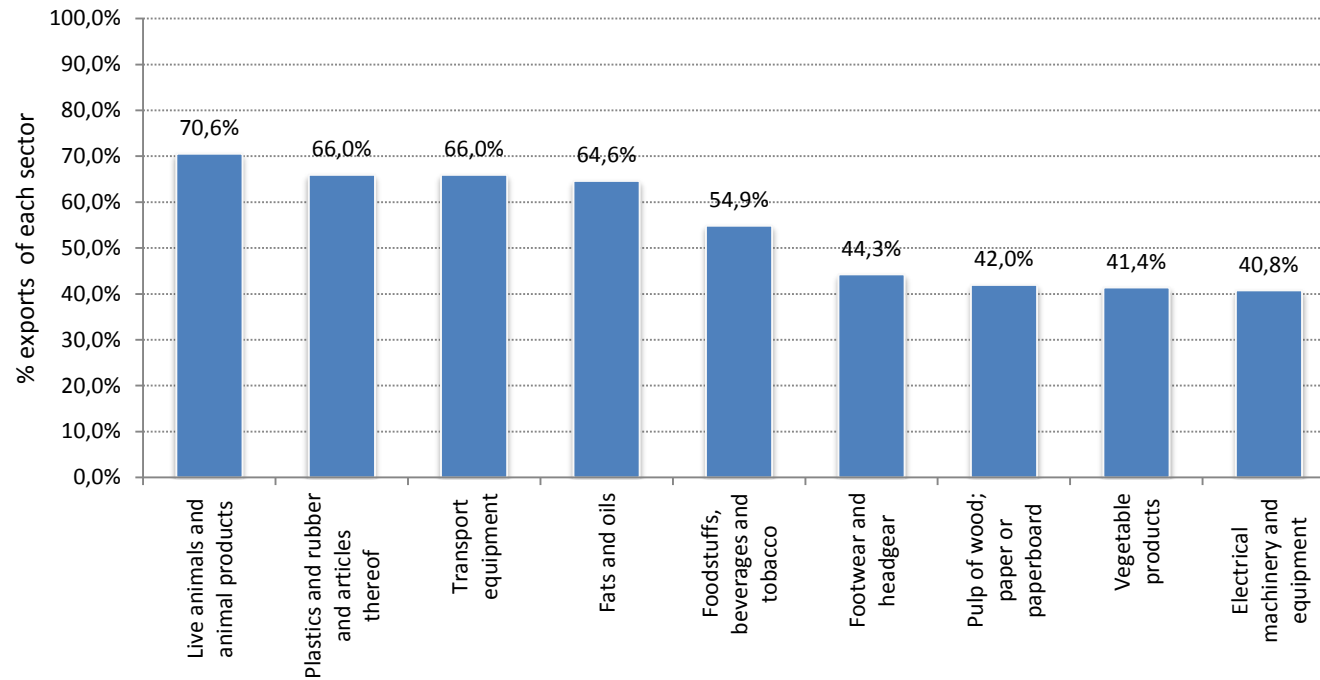
